Subject: **Request for information on my appeals for restoration of salary and Switch Back from Tenure Track System (TTS) to BPS-21.**

Please refer to decision of the Syndicate held in their 95th meeting of 25-10-2016 allowing the undersigned and others for switching back from TTS to graded position as per statutory procedures/provisions, communicated to the undersigned vide Registrar UAP letter No,656/SI/UAP dated 1-12-2016. The undersigned was not treated at par with other colleagues, six of whom were provided relief vide letter No. 627/R/UAP dated 10-2-2017 and one later on, probably due to my innovative contributions (Annex A, B, C). **The University administration instead of providing me my due right, stopped my salary since Feb 2018 without any justification or approval of the Competent Authority.** This has been the worst type of discrimination to myself and my family.

I could not get any response to my following appeals, etc. You are requested to provide the relevant records of processing of my cases (appeals, etc, Annex 1 to 10), as provided under KP Right to Information Act NO.XXVII of 2013, please:

1. Appeal No.1 forwarded by the Chairman LM vide No.4366/LM/AUP dated 8-5-2017, and marked by the Registrar to AR-I for discussion.
2. Appeal No.2, endorsed by the Chairman LM and Dean FAHVS vide No.3018 dated 21-7-2017.
3. Letter of Chairman LM recommending release/adjustment of salary, endorsed by the Dean FAHVS vide letter No.1086 dated 6-4-2018.
4. Appeal No.3, dated 9-5-2018, as a top priority/immediate document.
